- The Forms are limited to the matters, things or actions that are required to be undertaken under the Act or the regulations. This includes making applications and compliance actions. Most of the forms are for the exclusive use of council officers or building surveyors.
- Exercise care when completing Forms. Read the Act or regulations, and in particular the section or regulation referred to, before use. This will provide a check to ensure that the user understands the Form being used, and that all relevant information is included.
